• Planning is already underway for the 2019 ROME Conference. We look forward to hosting the event in Rhode Island this year.





Admission into UNECOM Interviews

The RISOPS Student Recruitment and Placement Committee holds interviews for students each year who are applying for admission to UNECOM. Interviews are usually held on the 3rd Saturday of September. After the committee completes the interviews, recommendations letters are sent to the UNECOM admissions office. The letters are also available to be sent to other schools that the interviewee would like them sent to. Applying to osteopathic school is a competitive process.
