



UPDATE: KENT HOSPITAL

Kent Hospital, a teaching affiliate of the University of New England College of Osteopathic Medicine, is home to three residency programs and a fellowship. Family Medicine, Emergency Medicine and the Hyperbaric Medicine Fellowship programs opened their doors in 2008 and have since successfully graduated their respectful residency classes. The Internal Medicine program is currently in its second year.

Family Medicine is a three-year program approved by the AOA for nine positions.

Most of the rotations are completed at Kent Hospital. Additional affiliations include the Naval Health Clinic of New England, local nursing homes, federally qualified health centers and clinics. Internal Medicine is a 3-year program approved by the AOA for nine positions. Electives are offered in all medical subspecialties as well as wound care. In addition, there is a unique opportunity to rotate on the obstetric medicine service at our sister hospital, Women and Infants.

Emergency Medicine program is PGY1-4 format, approved by the American Osteopathic Association and the American College of Osteopathic Emergency Physicians. The program is approved for 26 resident positions. In addition to Kent Hospital, EM residents rotate through several other satellite emergency departments affiliated with the EMRP during the program including Tufts Medical Center, Massachusetts General Hospital, St. Barnabas Hospital in the Bronx, St. Anne's Hospital, Boston Children's Hospital, and Women & Infants Hospital. EM residents have put this relatively new program on the national map taking first place in 2012 FOEM research paper competition as well as first place in 2012 ACOEP spring seminar resident case poster presentation.






■ The Rhode Island Department of Health has begun enrolling all licensed practitioners authorized to directly access the Prescription Monitoring Program (PMP). The PMP is a new, free and secure web based tool which allows prescribers and pharmacists to access information about controlled substances that have been prescribed to a patient and how they have been filled. ■ **EMR Update:** February 28, 2013 is the last day to attest for EHR Meaningful Use for 2012. If you participated in the Center for Medicare and Medicaid (CMS) Medicare Electronic Health Record (EHR) Incentive Program in 2012, the last day to complete your attestation to get paid your incentive is February 28, 2013. You must have completed your 2012 reporting period by December 31, 2012. Category 1-B Credit is approved for the webcast EMR Implementation - Lessons Learned. Snapshot of Rhode Island's Health

According to the 2012 Edition of the United Health Foundation's America's Health Rankings®, Rhode Island was identified as the 10th healthiest state in the nation. Specific measures follow:

- 8.4% Adults who "have...been told by a doctor that [they] have diabetes." Does not include pre-diabetes or diabetes during pregnancy.
 - 11.8% Percent of population that does not have health insurance privately through their employer or the government.
 - 20.0% People over the age of 18 who smoke on a regular basis.
 - 25.4% Estimated to be obese with a body mass index (BMI) of 30.0 or higher.
- Per 100,000 population:
- 172.4 Number of primary care providers (including general practice, family practice, OB-GYN, pediatrics, and internal medicine)
 - 185.4 Number of deaths due to all causes of cancer
 - 256.6 Number of murders, rapes, robberies and aggravated assaults
 - 261.5 Number of deaths due to all cardiovascular diseases, including heart disease and stroke

Cranston General Hospital was established in 1933 as the Osteopathic Hospital of Rhode Island. Twelve osteopaths pooled their resources to purchase a mansion on Broad Street in Cranston, Rhode Island. The original hospital had 6 physicians, 12 nurses and could house 18 patients. The hospital grew steadily through the 1940s, 1950s, and 1960s adding new wings in 1954, 1961, 1963, 1967, and 1979. In 1947 the hospital became Osteopathic General Hospital and in 1971 the Cranston General Hospital. The hospital closed September 20, 1993 due to bankruptcy.

The Undersea and Hyperbaric Medicine Fellowship Program is approved by the AOA and offers a 12 month curriculum with a clinical focus on wound care, dive medicine and hyperbarics. Kent Hospital is the only 24-hour-a-day hyperbaric medicine referral center for southern New England and is the busiest one in the region.
